

A Tribute To Roger Lord

My first opportunity to see Roger Lord in action occurred in the late 1970's in the nickel game at



the Dorchester. The opponents reached four hearts after Roger had overcalled. I was holding a Yarborough with 9xxx of hearts and thought \$31 was lost. Roger looked at dummy and at his hand, with three tricks, playing to promote my nine for a \$5 gain. His only comment was "I didn't see any other play for four tricks."

Roger has enjoyed success at all levels of bridge including a national title and two seconds: the NAC Silver Ribbon in 2002 with Alan Popkin, the Grand National Teams in 1973, and the NAC Open Pairs in 2003 with Jackie Sincoff, respectively. He has won the District 8 Grand National Teams at least eight times including the last three, and he won the District 8 NAOP three times. Roger has numerous regional and sectional wins to his credit.

Roger's most frequent partners are Jackie Sincoff and Richard Riezman. They play a strong NT, four card majors, and sound opening bids in first and second seat. In case you haven't checked their convention card, they also play a "few" gadgets ...enough to fill the margin of their convention card.

Roger is a tough opponent and a great teammate. As an occasional partner and frequent teammate, I want to thank him for the many great moments he has given me "at the table."
